

# **Terms and Conditions 2025**

## **Enrolment Conditions**

- If you are registering for the whole term at Newcastle Flamenco Dance School (the term is a 10-week period, with 10 classes of 1 hour per week), a registration fee of \$40 for individual enrolment and \$65 for family enrolment will apply to cover the costs of administration, venue hire and insurance cover.
- If you are attending a single casual (drop-in) or trial class, the registration fee will not apply.
- Please ensure you enrol before the commencement of terms, to avoid missing the initial classes and learning the basics that are taught at the beginning of the course.

There are 4 terms throughout the year, each term lasts 3 months and they normally correspond to public school terms. Please check the terms' dates on the Newcastle Flamenco Dance FB page and/or on the website.

Terms and timetables for classes will be displayed on the website <a href="www.newcastleflamencodance.com">www.newcastleflamencodance.com</a> and will also be periodically posted on social media.

## Schedule of Fees

Basic flamenco classes (Kids', Absolute Beginners, Beginners and Intermediate adults' classes) run for a specific date range or a term.

Gypsy Gym workout classes will follow the term times; however, the classes do not require a commitment to full terms and students can enrol at any time.

## **Terms of Payment**

- All advertised prices include GST.
- Fees are due to be paid in full at the beginning of each term, by Week 2.
- Payments can be made via EFTPOS, cash, or direct online deposit (Please contact the instructor for bank details, or to arrange payments at classes by cash and EFTPOS).
- Please note: Term fees not paid by the end of each Term will incur additional \$15 per fortnight late payment fee until the outstanding amounts are fully paid.

## Change of location and times

We reserve the right to change the location of the classes or timetable for classes from time to time. This may or may not happen on annual basis, or due to unforeseen circumstances.

We will endeavour to give you a timely notice well in advance of proposed change of venue, in writing via email and on social media.

## Cancellations and Refunds

No refunds will be given for missed classes **due to vacation**, **holidays**, **sickness etc**. Non-attendance does not constitute withdrawal. Should a student decide to discontinue lessons, a **minimum of 2 weeks' notice is required if they have started a term**. Registration fee **will not be refunded.** 

In the event of a class being cancelled by the Newcastle Flamenco Dance every effort will be made to avoid inconvenience by offering alternative dates and times for cancelled classes.

### Code of conduct

All students and instructors are expected to behave and interact in a courteous manner. We reserve the right to refuse entry to anyone who acts inappropriately and breaks the studio code. Examples of unacceptable and inappropriate behaviour are as follows:

- Threatening or harassing others
- Damaging premises
- Use of illegal substances or being under the influence of alcohol.

#### **Limitation of liability**

Under the Australian Consumer Law, we guarantee that Newcastle Flamenco Dance services are provided with due care and skill. However, there are circumstances where we would like to delimit our rights and responsibilities towards students, as described below:

- While we exercise all reasonable care in the conduct of the classes and they are not physically demanding, please make sure that you are physically and mentally fit to attend a dance class, as any physical activity may involve a risk of injury.
- Students enrolled into children's classes are required to be accompanied by a parent or guardian when at the studio.
- All children are to be collected from the studio, and under no circumstances are the children permitted to wait on the street.
- Photos may occasionally be taken of the students to be used on our website and Facebook page please
  advise if you/your child do not wish to be included in any photos.
- Please keep your belongings safe, in your line of sight and nearby, and do not bring valuables into the studio. We cannot accept responsibility for any loss or damage to your belongings while you are at the studio.
- You will be held responsible for any damage that you or persons who accompany you cause through a wilful
  act or negligence.
- We are not liable for any loss or damage to your vehicle or its contents if you are parked in front of the building premises or in the nearby areas.

These terms may be subject to change. Please make sure you read and accept the current version of the Terms before booking the classes. By booking your spot and attending classes, you agree to these Terms and Conditions.
